13. DESCRIPTION OF THE EQUIPMENT OR PROTECTIVE SYSTEM

The APT 500, APT 590, SPT 900 and SPT990 Series level transmitters are designed for monitoring liquid levels and pressures, based on a micro-electro-mechanical (MEMS) piezo-resistive cell.

The pressure measurement cell is isolated from the process by a diaphragm with an internal fluid fill transmitting the process pressure to it. Temperature compensation and zero correction are applied during manufacture by laser trimming of compensation resistors.

The output from the measurement cell is converted by an internal circuit to a 4-20mA signal which is scaled to the user requirements.

The sensor is fully encapsulated internally and may be manufactured from a choice of construction materials for the wetted parts.

The APT 500 and SPT 900 are identical in mechanical and electrical construction.

The APT 590 and SPT 990 are identical in mechanical and electrical construction and differ from APT 500 and SPT 900 in electrical construction only.

The model code is defined as follows:

APT 500/I, SPT 900/I, APT 590/I and SPT 990/I – Intrinsically Safe, ATEX certification

APT 500/X, SPT 900/X, APT 590/X or SPT 990/X – Intrinsically Safe, IECEx certification

The model code may be followed by other alpha-numeric characters, to define other features of the product.
